

#### **ENTRIES**

Only the Show Secretary and members of her household are ineligible to enter or handle dogs at this Specialty.

Fees must accompany entries. The Club and/or Show Secretary assume no responsibility for wrong or incomplete information given on the entry form by the owner or agent.

All entry changes must be submitted in writing to the Show Secretary before closing. Entry fees will not be refunded in the event of error or cancellation of entries received after published closing date, nor in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by the Show Committee. If, because of riots, civil disturbance or other acts beyond the control of the management, it is impossible to open or complete the show, no entry fees will be refunded.

A Recording Fee will be required for each dog entered at any Licensed or Member Club Show and Obedience Trial. The Recording Fee is to be collected by the show-giving club and paid to the American Kennel Club

#### **JUDGING**

Exhibitors are responsible for having their dogs at ringside for judging when the steward calls for the class. Judges need not wait for dogs holding up class judging.


