BRACE COMPLETION

The quality of the dogs, their similarity and their ability to be shown together are of primary consideration. An examination of each dog is necessary to determine quality, similarity, and if there is a condition that would require disqualification or excusal under the *Rules*, AKC policy or the breed standard.

All braces and teams must be moved to determine their ability to show together. Although dogs need not be identical, the final determination should be based on their overall similarity and uniformity standing and moving.
